To make a Freedom of Information (FOI) request to Legal Aid Ontario (LAO) under the *Freedom of Information* and *Protection of Privacy Act* (FIPPA), complete this form and drop it off, or mail it, along with the \$5.00 application fee (if required) to:

LAO will only accept FOI / FIPPA requests if received by regular mail or dropped off in person at the Provincial Office. LAO will not respond to requests via telephone or email.

LAO will mail you a decision within 30 days of receiving this request, unless an extension is sought. Please note that confidential client information is generally exempt from disclosure to third parties under the *Legal Aid Services Act* (1998).

Depending on your request, additional processing fees may be required. We will send you a fee estimate if your processing fees will be more than \$25. When processing fees are over \$100, we may require a deposit.
